

**Notice for Inviting Tender of Hiring of Consultants For Civil Works at DHABEJI SPECIAL ECONOMIC ZONE**

SBI intends to acquire the services of an experienced engineering consultant firm for the design and construction supervision of (AS SCOPE) all the civil works at Dhabeji Special Economic Zone. Applications are invited from interested consultant firms/organizations for the service Design and supervision of civil works.

The consultant`s scope of services will include the following;

- Detail design & Supervision for civil works in accordance of concept plans / preliminary design.
- Technical, Financial, Economical and Legal inputs.
- Conduct complete bidding process (Prequalification of Contractors, Evaluation of bids, Preparation of detail bid evaluation reports including clear recommendations, Negotiations and assistance in award of works, any other relevant/mandatory task).
- Management of Contractual issues

All application must include, as a minimum, the following information.

1. Name of the organization, address, contact person, telephone and fax number, date of establishment, copy of certificate of incorporation or registration, organizational set-up and fields of specialization.
2. Type of entity (Partnership, or private or public limited) along with details of corporate profile (including joint venture partners, if any) and details of consultancy services undertaken.
3. The Consultancy Firm should submitted the documentary proof of the following with their proposals;
  - Valid NTN Certificate from Income Tax Authorities.
  - Valid SRB Certificate from concerned Authorities.
  - Valid Registration Certificate from Pakistan Engineering Council (PEC) for the year 2018 bearing relevant codes including 1203 and 1204.
  - Should be in Business for last 15 years or more.
  - Affidavit shall be submitted for Consultant firm not Blacklisted on any Project or by any organization.
  - Should have completed Master planning, detailed designing and construction supervision of at least 1(One) projects of similar nature for minimum 50 acres land.
4. The Request for Proposal (RFP) can be obtained from below addressed upon payment of Rs. 2500/- (non-refundable) in the shape of Pay order in the favor of "**Sindh board of Investment**" address given below up till November 15, 2018 during working hours.
5. The interested firms are requested to submit their Technical and Financial proposals by till November 16, 2018 12 noon. The Technical Bids would be opened on the same day at 13:00 Hrs. Delayed/ conditional/telegraphic bids will not be entertained.
6. Financial bids of bidders, who fail to qualify in technical evaluation, shall be returned unopened. However financial bids / proposals of qualified bidders would be opened on the date & time to be intimated in due course of time.
7. The SBI reserves the right to accept or reject any or all applications as per SPPRA rules. Any wrong or misleading information provided as part of the application shall lead to disqualification of the firm from competing for the above consultancy. If such wrong or misleading information is discovered later, following conclusion of an agreement/Contract, it may lead to cancellation of such agreement/Contract.
